PREREQUISITES:

Basic knowledge in Windows operating system, spatial thinking (geography), and soil science or natural resource management, or similar discipline.

COURSE OBJECTIVES:

To provide students with the basic concepts of, and experience in using, the ArcGIS geographic information system (GIS) and geospatial methods as applied to land resource management issues.

In this course you will gain ample hands-on experience in using ArcGIS and geospatial analysis using real-world spatial data. Learning about GIS is fun and a creative process. Discovery learning through work with geospatial data and applications is a focal point in this course. Practical training through GIS

practice assignments, a GIS project, and knowledge in GIS science form important learning elements in this course. After course completion, you will be able to independently conduct your own GIS projects and find solutions to basic geospatial problems.

EXPECTATIONS AND GRADING POLICY IN THIS COURSE:

It is highly recommended that on-campus students attend the classroom (face-to-face class sessions) and online students attend the live chats (Zoom). The etiquette in the classroom and in the Zoom meetings involves to switch off digital devices and reduce other noises (TV, music, etc.) that may interrupt class activities. Be mindful to participate in dialogue, Q&A, and focus attention on the course topics during class time.

All students enrolled in this course are expected to study the learning material provided on the course web site, videos, and textbooks. Attendance means to login/come to class punctual when the class starts and stay until the end of the scheduled class time.

The discussion board on the course web site will host multiple 'creative geospatial assignments' aimed to stimulate spatial reasoning and thinking skills.

<u>The GIS project</u> shall be conducted using the ArcGIS Pro software available through UF Apps or UF student licensing of the software. <u>Students are expected to work independently on their hands-on GIS creative assignments and GIS project and produce their own reports</u>. Copying of results or text (reports) from other students or the Internet is considered plagiarism and results in zero points. In this course the Turnitin anti-plagiarism software is used.

<u>Use of artificial intelligence (AI) tools</u>, such as ChatGPT or Bard, Large Language Models (LLMs): There is an open policy to make use of AI models for assignments focused on writing. If you make use of them provide a citation and acknowledgement to the AI tool/app you used to write a post or paragraph in a report (i.e., make it transparent that it was not you who produced the text but a machine). Note that the quality of AI-LLM differs widely and some issues have been recognized (e.g., hallucinations / false claims made by AI-LLMs, mismatched citations and arguments, lack in transparency where the data or information come from (i.e., insufficient or improper sources), missing or incorrect citations, etc.).

In this course, any assignment that involves written text adheres to the <u>ethical and scientific standards</u> <u>of academic writing</u>. Arguments, assertions, facts, interpretations, and data are expected to be properly referenced with citations and references that allows tracking them down to an original source (creator, author, publisher). Reliable sources (e.g., journal articles with unique Digital Object Identifiers (DOI), peer-reviewed textbooks, and other peer-reviewed scientific publications) are preferred over soft sources (e.g., web sites that can change any moment). Geospatial data also need to be referenced with proper citations when they are used in a GIS project or assignment.

The <u>IT staff of the University of Florida</u> provides services to assist with technical problems (e.g., GIS software and UF apps). The instructor does not have administrative permissions to fix IT problems. Act

swiftly to contact UF IT staff (UF Helpdesk: 352-392-HELP or helpdesk@ufl.edu) if technical problems arise to allow sufficient time for submission of assignment reports and posts.

<u>Late submissions of assignment or project reports</u> will result in 15% reduction of points within 24 hours late submission, and 30% reduction of points between 24-48 hours late submission. After more than 48 hours late submission zero points will be assigned. All reports need to be submitted through the course website (UF eLearning). Submissions via email attachments will not be accepted. In case of a medical emergency or extraordinary circumstances contact the course instructor ASAP to avoid loss of points.

COURSE MODULES AND LEARNING OBJECTIVES:

Module 1: Principles of Geographic Information Systems

Explore the basic elements of spatial data and how they are implemented in a GIS. Geographic concepts are introduced that provide the framework for GIS analysis.

Module 2: Geodesy, Datums, Projections and Coordinate Systems

Gain understanding why projections and coordinate systems are important in spatial modeling. Examine various coordinate systems and map projections to display and represent spatial datasets.

Module 3: Maps, Data Entry, Editing, and Output Building in a GIS Database

Discover how spatial data are created through digitizing and how geospatial data are entered into databases. Examine how spatial data are documented by meta data and output maps are cartographically presented.

Module 4: Spatial Data

Discover what kind of spatial datasets are available at local, regional, continental, and global scale for use in ArcGIS. Explore soil and land resource specific geospatial datasets.

Module 5: Attribute Data and Tables

Gain knowledge about relational databases and how to work with spatial data tables. Explore soil databases that use the relational database concept.

Module 6: Spatial Data Analysis

Explore various vector-based processing functions to conduct GIS analysis.

Module 7: Raster Analysis

Explore various raster-based processing functions to conduct GIS analysis.

Module 8: Spatial Estimation

Estimate site-specific measurements across a region through various interpolation methods. Understand the distinctions between global, local and geostatistical methods to interpolate spatially explicit data.

Module 9: Spatial Models and Modeling

Discover the potential of complex spatial models with ArcGIS that integrate multiple spatial datasets, use sequential geoprocessing functions (e.g., suitability analysis), spatio-temporal models, or use machine learning AI approaches.

Module 10: Geospatial Data Standards and Data Quality

Explore various geospatial data standards, learn how to assess spatial data accuracy, and what kind of errors may occur in spatial modeling.

ATTENDANCE AND MAKE-UP WORK

Absences

Students are responsible for satisfying all academic objectives as defined by the instructor. Absences count from the first class meeting.

In general, acceptable reasons for absence from or failure to participate in class include illness, serious family emergencies, special curricular requirements (e.g., judging trips, field trips, professional conferences), military obligation, severe weather conditions, religious holidays and participation in official university activities such as music performances, athletic competition or debate. Absences from class for court-imposed legal obligations (e.g., jury duty or subpoena) must be excused. Other reasons also may be approved.

You cannot participate in classes unless you are registered officially or approved to audit with evidence of having paid audit fees. The Office of the University Registrar provides official class rolls to instructors.

If you do not participate in at least one of the first two class meetings of a course or laboratory in which you are registered, and you have not contacted the department to indicate your intent, you can be dropped from the course. You must not assume that you will be dropped, however. The department will notify you if you have been dropped from a course or laboratory. You can request reinstatement on a space-available basis if you present documented evidence.

The university recognizes the right of the individual professor to make attendance mandatory. After due warning, professors can prohibit further attendance and subsequently assign a failing grade for excessive absences.

Religious Holidays

The Florida Board of Education and state law govern university policy regarding observance of religious holidays. The following guidelines apply:

- Students, upon prior notification to their instructors, shall be excused from class or other scheduled academic activity to observe a religious holy day of their faith.
- Students shall be permitted a reasonable amount of time to make up the material or activities covered in their absence.
- Students shall not be penalized due to absence from class or other scheduled academic activity because of religious observances.

If a faculty member is informed of or is aware that a significant number of students are likely to be absent from class because of a religious observance, the faculty member should not schedule a major exam or other academic event at that time.

A student who is to be excused from class for a religious observance is not required to provide a second party certification of the reason for the absence. Furthermore, a student who believes that he or she has been unreasonably denied an education benefit due to religious beliefs or practices may seek redress through the student grievance procedure.

Illness Policy

If you are absent from classes or examinations because of illness you should contact your instructors. You should contact your college by the deadline to drop a course for medical reasons. You

can petition the Dean of Students Office to drop a course for medical reasons. The university's policy regarding medical excuse from classes is maintained by the Student Health Care Center.

Twelve-Day Rule

Students who participate in athletic or extracurricular activities are permitted to be absent 12 scholastic days per semester without penalty. (A scholastic day is any day on which regular class work is scheduled.) Instructors must be flexible when scheduling exams or other class assignments. The 12-day rule applies to individual students participating on athletic or scholastic teams. Consequently, a group's schedule that requires absence of more than 12 days should be adjusted so that no student is absent from campus more than 12 scholastic days.

If you previously have been warned about absences or unsatisfactory work you should not incur additional absences, even if you have not been absent 12 scholastic days. It is <u>your</u> responsibility to maintain satisfactory academic performance and attendance.

IN-CLASS RECORDINGS:

Our class sessions may be audio visually recorded for students in the class to refer back and for enrolled students who are unable to attend live. Students who participate with their camera engaged or utilize a profile image are agreeing to have their video or image recorded. A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
